Public Comment:

Brian Green STAC. He has been coaching in NJ for 40 years. He is here tonight to propose to the pool for use of our long course pool hours. He is looking for the days of Tuesday, Thursday and Sundays. The times he was looking for are 6:00 am to 9:30 am Tuesday, Thursday and Sunday 8:00 am to 11 am. He said he will offer the swim team free of charge clinics with his staff who will run them.

Brian said that he has sent the proposal to Mr. Kranz and Mr. Grimm to review.

Mr. Kranz asked him what approximate date he was looking to hold a long course practice. Brian said Memorial Day to August 4th is the time frame he is looking for.

Mr. Grimm mentioned using the large pool on Tuesday and Thursday 8:00 pm to 10:00 pm for their long course practice. Sunday will be a morning practice.

Mr. Grimm said that we will supply the lifeguards for the pool.
