5. Borough of Middlesex Master Plan Reexamination presented by Paul Ricci

Mr. Ricci stated that after the last meeting, the Acme property was added into the report as vacant property that needed to be occupied.

He stated that the previous power point presentation is now a 67 page document.

Mr. Ricci reviewed the Key Findings and Recommendations for the 2022 Master Reexamination Report Adoption:

- Lincoln Boulevard Redevelopment Plan Area
 - Board recommended Lincoln Blvd plan to reduce stories from five to three stories or less
 - Add recreation space
 - Mix use Development
 - Increase minimum size of apartments for 1 bedroom to 1,000sq.ft.
 - Townhouse to be permitted in plan
- Lincoln Statute
 - Define area of grass
 - Add parking signage
 - Improve Park area with benches
 - Put on open space inventory
 - Board won appeal on development at site
- Flood Control Plan Zoning
 - Add a policy statement
 - Lands that may be able to be used in future after Army Corps Project Completed
- Municipal Town Center
 - Potentially acquire Middlesex Presbyterian Church
 - · Municipal Land Fill site- inquire about solar
 - Also work with Cultural and Heritage committee- Veterans and Banners
- Policy Statements
 - Union Carbide Redevelopment Area
 - South Ave Redevelopment
 - Zero Lot Line Zoning
 - Open Space/Recreation Planning
- Zone Boundary Amendments
 - Referred to Appendix C-
 - Change RT zone and eliminate two family in district
 - McDonald's property to allow for townhouse possibly
- Zone Requirement Recommendations
 - Decrease lot coverage percentage
 - Increase principle building coverage percentages
 - In R60B zone increase lot size to 7,000 sq/ft and clarify provision
 - Recommended that lots should have principal building -not have contractor's yard
 - Update Redevelopment plan regarding new lighting requirements
- Other Amendments
 - Create policy for EIS (Environmental Impact Statements, Community Impact Statements, and Traffic Studies)
 - Update signage ordinance- include menu board for drive-throughs
 - Update tree ordinances
 - Have major applications provide post occupancy studies

Chairperson Conahan asked the Board Members for questions.

Member Dessino asked a question regarding low income housing and COAH.

Mr. Ricci gave a history of affordable housing and the Borough doesn't have a set number.

Chairperson Conahan opened the meeting to the public.

Rich Rutkowski, asked how the Lincoln Boulevard Redevelopment Plan fits into the Master Plan

Mr. Ricci stated that the Mayor and Council would need to adopt the recommendations, then the Mayor and Council would need to revise the Redevelopment Plan.

Mayor Madden, 39 Ramsey Rd., asking a question regarding lighting recommendations. He stated that Recycle Yard would not be moving due to FEMA and recommended that be taken out of Reexamination Plan, Borough working with Army Corp regarding parks. He stated that the Borough has lost pocket parks, maybe a walking park or sculpture park would be added.

Gene Hanania, asked about property tax abatement.

Mr. Ricci stated that only PILOT programs can be approved by the Mayor and Council.

Ms. Wilczewski, 168 So.Lincoln Ave. gave a history of the Lincoln Statute, as part of the Cultural and Heritage Committee she has been trying to register the Statute as a Landmark.

Mr. Ricci stated that a statement can be added to the Reexamination Plan regarding historical preservation.

Emil Vogt, asked why the Lincoln Boulevard Plan was needed and it keeps changing.

Mr. Ricci explained why the Borough chooses to have the Plan.

There being no further public comments, Chairperson Conahan closed the public portion of the meeting.

Chairperson Conahan announced that the Master Plan Reexamination Adoption would be at the next meeting on June 8, 2022.
