Chairman Gitler opened the meeting to the public.

Joyce Gehrke, Hazelwood School Librarian, requested that the Shade Tree Commission plant a tree for Lynn Charles, the Hazelwood School nurse, who worked 25+ years for the Board of Education and retired in January. The Principal and Mr. Mulvey have requested that the tree be planted in the back of Hazelwood School, and Ms. Gehrke indicated that they have a bench to place by the tree. The Commission agreed to plant a group of 3 trees which require low maintenance and are slow growing, possibly a maple or cucumber magnolia. The Shade Tree Secretary will contact Mr. Mulvey for proper approval and move forward on this planting. This will be the Borough's Arbor Day planting for 2018.

Seeing that there was no public participation, Chairman Gitler closed the public portion of the meeting.

Mr. Gitler made a motion to approve the February 8, 2018 Shade Tree Meeting Minutes seconded by Mr. Johnson and carried by a unanimous vote of the Commission.

Mr. Bond moved to acknowledge the February & March, 2018 Finance Report seconded by Mr. Gitler and carried by a unanimous vote of the Commission.

Communications

<u>1.</u> 417 Melrose Avenue – Commission indicated that there was no tree at this location.

- 2. 237 Greene Avenue Commission agreed that the maple tree should be removed and replaced.
- 3. 212 Lucia Street Commission agreed to keep this tree as a follow up and look at it after it has leafed out.
- 4. 420 Runyon Avenue Commission felt that the branch has been removed and no additional work is needed.

- 13. 437 Giles Avenue This item was tabled and commission will look at the tree in front of this property that they feel is dead.
- 14. 350 Bound Brook Road Commission agreed that they should trim broken branches on the tree at the corner of Pond.
- 15. 125 South Woodlawn Avenue Commission agreed that the tree with hanging branches should get a 2" prune.

- 1. Request from Joyce Gehrke for a tree at Hazelwood School Ms. Gehrke attended the Public Portion with her request.
- 2. 2018 Shade Tree Budget The commission discussed the budget, which was rolled back to last year's amount. Mr. Gitler stated that last year we were able to meet our budget because \$9,000 was taken from the Tree Replacement Fund to plant in the Fall. He indicated that with a \$25,000 budget we are no longer in compliance with Tree City USA, and therefore cannot meet requirements of the Tree Management Plan. For Tree City USA we must spent at a minimum \$2 per capita per resident (13,635) and for the Tree Management Plan we must plant a new tree for each one replaced. Commission also requested that Councilman Mikolajczyk bring to the governing body the amendment to the Shade Tree Ordinance which would increase the fines to remove Shade Trees and these fines would go into the Tree Replacement Fund. The Commission is also concerned with the procedure to enforce the ordinance. (Possibly Commission member send email to Code Enforcer to issue violation) Councilman Mikolajczyk will bring this matter up to the governing body at their May meeting and report back to the Commission.
- 3. Commission determined that due to the constraint on the budget, the Secretary will bring back all estimates from Predator and the Commission will prioritize the work that is required be done to the shade trees to the next Shade Tree meeting.
- 4. Councilman Mikolajczyk also suggested that he discuss with the Mayor that if it is possible that any tree work that is storm related could be added to the Emergency Appropriation Bond.
- 5. Arbor Day Proclamation Chairman Gitler signed the 2018 Arbor Day Proclamation.
- 6. Commission also plan to work on a Grant to help fund a "tree inventory" in town which would include specie of tree.

Mr. Gitler moved to adjourn the meeting, seconded by Mr. Bond and carried by a unanimous vote of the Commission.

- 2. Arbor Day Planting Commission agreed that the planting at Hazelwood School would be for Arbor Day and they will be planting 3 October Glory Maple Trees.
- 3. Shade Tree Ordinance Amendment Enforcement Councilman Mikolajczyk indicated that he has looked at the ordinance and he feels that there is no mechanism to enforce. Commission is concerned that this ordinance is on the books, the Code Enforcement Officer is the designee to issue fines, and they do not want residents to remove/prune shade trees on the borough right of way without shade tree approval. Because the Code Enforcement Officer is not familiar with dead/diseased trees, they would like to have the commission members look at trees and bring these properties to the attention of the Code Enforcement Officer. The commission suggested creating a form for them to fill out about the location of the tree and indicate if resident has pruned, cut down or done anything to the tree without shade tree approval. The shade tree would give the form to code enforcer and/or designee and she can notify the resident. They would like to start with revising the ordinance and create a mechanism to begin the process of enforcing fines. Also, Councilman Mikolajczyk will put information in his "Our Town" article to discuss the Shade Tree Commission and their responsibilities. The commission also recommended that if tree work is approved by the Mayor, he would like to have him inform the Secretary, so that

they do not go to have the Code Enforcement Officer issue a fine to residents that had the prior approval of the Mayor. They would like the form to reflect that it was a Mayoral removal.

The Commission's goal is to have the residents comply with the ordinance by raising the fines and include the cost of a replacement tree. The commission's proposal includes: Step 1 – increase fine, Step 2 – make form and bring to next This form will include a section in it for the code enforcer which indicates where the resident did not comply with the ordinance. Dan Gitler will prepare a form to be approved at the next meeting.

Councilman Mikolajczyk will discuss with Mayor DiMura the mechanism that the Commission would like to enforce to move forward with this plan.

New Business

- 1. 2018 Shade Tree Budget Commission discussed the \$25,000 budget and that additional funds will be needed to meet their Tree City USA requirements. As they must plant a tree for each tree removed, the commission will now be prioritizing their tree work to keep the budget in line and keep up with the replanting.
- 2. Home Town Day Possible Shade Tree Booth (July 21, 2018) Commission will discuss this at the June, 2018 Meeting
- 3. Tree Management Plan Mr. Gitler discussed the management plan, and gave an overview of what is needed to complete for 2018. He mentioned that the commission needs to do a canopy assessment this year, and members need to go out and assess the trees. Also, the commission discussed the Grant that they would like to complete, which if awarded would enable the town to receive up to \$35,000 to be used for anything needed for the commission. The commission is looking to use any grant funds that they can get for additional planting and for creating a "tree inventory".

- 6. 9 Lauri Lane Commission will look at this tree to see if it is dead or diseased and report back.
- 7. 206 Walnut Street Mr. Bond reported that the red maple should have the overextended pieces reduced.

1. Shade Tree Ordinance Amendment – This ordinance is scheduled to be adopted at the December 18, 2018 Regular Meeting of the Mayor and Council. New Business

- 1. 2018 Shade Tree Budget Commission received an additional \$3,000 to increase their 2018 Budget to \$28,000. There is still \$4,275 of outstanding work (removals & pruning) from 2018. This work will be encumbered in January from the 2019 Temporary Budget.
- 2. Status of 2018 Fall Planting Boltzer planted 16 trees this year in December and 3 trees for Arbor Day.
- 3. Update on Tree City USA Status Application for Tree City USA has been submitted. Chairman Gitler indicated that the Commission should work on the CSIP Grant immediately, which could help fund a program to create the borough's tree inventory.
- 4. Tree Management Plan Report (2018) Commission will discuss this Report at the January, 2019 Meeting.
- 5. Status of the Liberty Elm Tree Planting for 2019 Commission will be receiving 10 Liberty Elm Trees that they purchased in 2017. Chairman Gitler will look into

when we can receive these trees, and the secretary will ask our contractor what the charge would be to plant these trees.

- 6. Events for 2019 Commission discussed Community Day, the Borough Street Fair and any additional opportunities where the Commission could take part.
- 7. Commissioner Bond reported that there is a new tree regional tree police that will be inspecting contractors to be sure that they comply with the new law requiring the LTCO Numbers be posted on their construction vehicles (trucks).
- 8. Chairman Gitler reported that he would like each commissioner to find 10 planting locations in the borough each so that for 2019 we will have begun to create an inventory to replenish our borough trees. This is a requirement in the Tree Management Plan.
- 9. Commission also discussed that when we solicit again for bids for tree planting, the specifications include that the trees each have burlap deer protection.
- 10. Councilman Mikolajczyk stated that changes are happening in the borough this year, and he did not know if he would be the 2019 liaison, but enjoyed working with the Commissioners that have volunteered for the Shade Tree.

Mr. Gitler moved to adjourn the meeting, seconded by Mr. Bond and carried by a unanimous vote of the Commission.
